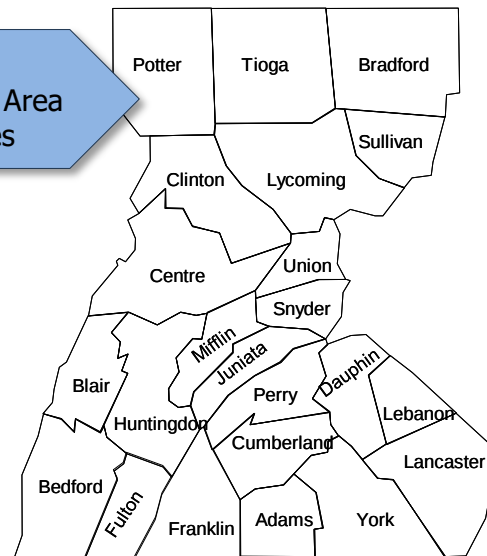

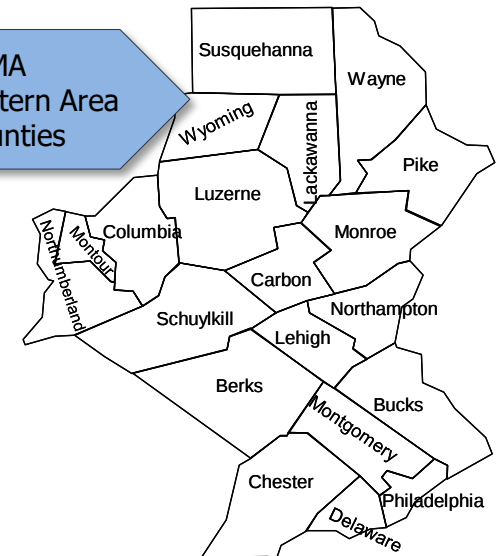
PEMA Western Area Counties
